(d) Introduce "Disc Parking Places, Waiting Limited to 2 Hours, Return Prohibited within 2 Hours, 8.00 am – 6.00 pm, Monday – Saturday, Residents Exempt" on parts of the following roads in Cockermouth: -

 (g) Remove "Disc Parking Places, 8.00 am 6.00 pm, Monday Saturday, Waiting Limited to 1 Hour, Return Prohibited within 1 Hour, Residents Exempt" on part of Fletcher Street (to become "No Waiting At Any

 (h) Impose "No Stopping on School Entrance Markings, 8.00 am 6.00 pm

- (h) Impose "No Stopping on School Entrance Markings, 8.00 am − 6.00 pm, Monday − Friday on part of Moor Road, Great Broughton;
- (i) Impose "No Waiting or Loading or Unloading At Any Time" on part of South Street, Cockermouth;

- (j) Designate a "HGV Parking Area, 6.00 pm Midnight and Midnight 7.00 am, and a Passenger Carrying Vehicle (PCV, ie. buses) Parking Area, 7.00 am 6.00 pm" on part of Wakefield Road, Cockermouth (to replace the existing Goods Vehicle Parking Area);
- (k) Impose "Prohibition of Driving, 9.00 am 4.00 pm on a Saturday (but only when the Market operates)" on parts of Market Place, Cockermouth;
- (1) Introduce "Disc Parking Places, 8.00 am 6.00 pm, Monday Saturday, Waiting Limited to 1 Hour, Return Prohibited within 1 Hour (but not when the Market operates on a Saturday)" and "No Waiting, 8.00 am 6.00 pm on a Saturday (but only when the Market operates) on parts of Market Place, Cockermouth;
- (m) Introduce a "Loading and Unloading Area for Business Purposes Only,
 8.00 am 6.00 pm, Monday Saturday" on parts of Lorton Street and
 Main Street, Cockermouth; and
- (n) Introduce "No Waiting Except for Hackney Carriages, At Any Time" on part of Main Street, Cockermouth.
- NB: (1) Residents' exemptions will not now apply to any limited waiting disc parking at Main Street, Market Place and Station Street, Cockermouth, nor to the new limited waiting disc parking area proposed on South Street, Cockermouth.
 - (2) Bank Holiday exemptions to waiting restrictions will continue NOT to apply as has been the case since the 2003 Consolidation Order.
